In the event of any CPIO proceeding on leave or post lying vacant for a period of more than three days, his/her immediate superior will discharge the duties of CPIO during such absence and the Appeal will lie to the next higher authority accordingly, in such cases individually. In case of absence of First Appellate Authority for one week or more, the link officer looking after the work of the regular incumbent will act as the Appellate Authority during the particular period. The CPIOs shall also submit quarterly returns for each quarter by 15<sup>th</sup> of the month after each quarter, including details of all online and offline applications.
