In case of absence of First Appellate Authority for one week or more, the linkofficer looking after the work of the regular incumbent will act as the Appellate Authority during the particular period. The CPIOs shall also submit quarterly returns for each quarter by 15th of the month after each quarter, including details of all online and offline applications.
