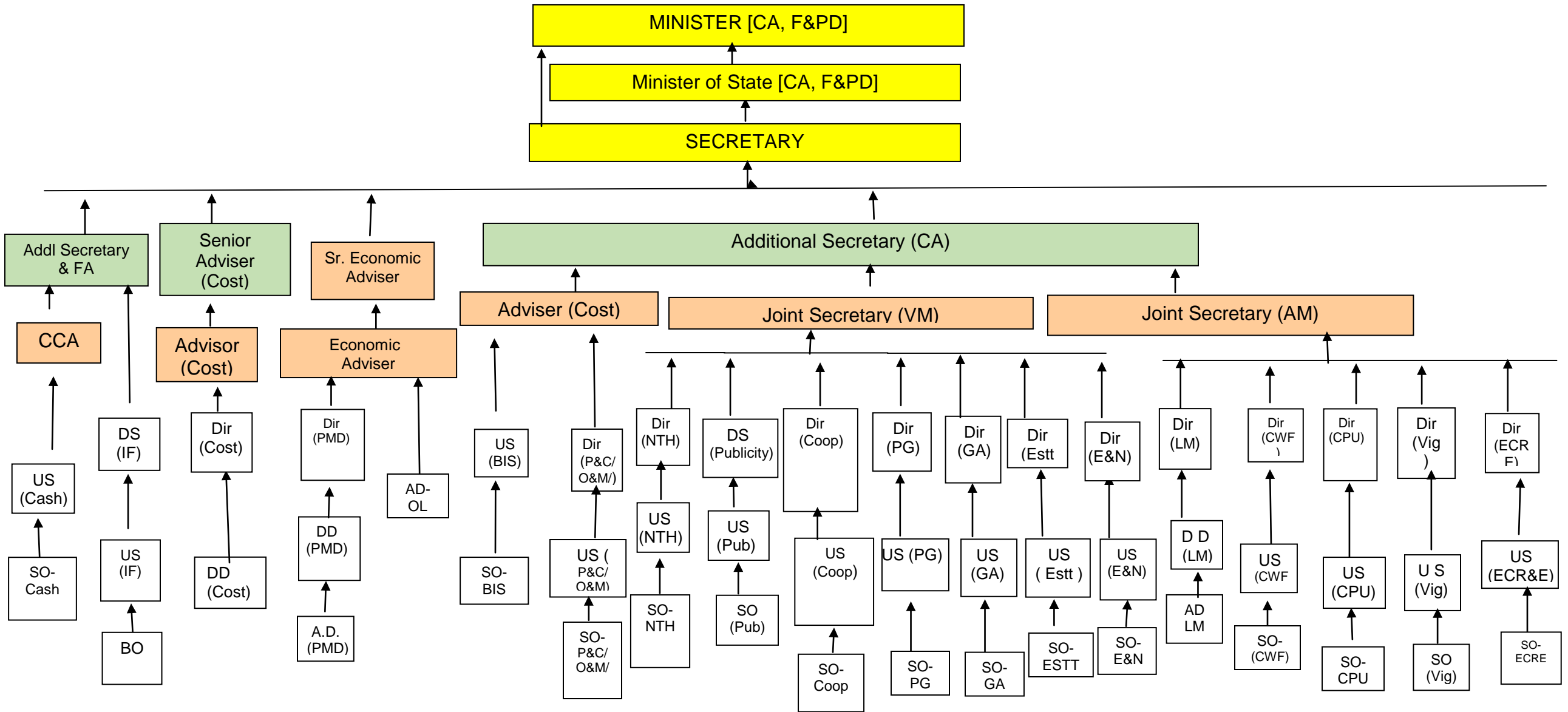


ORGANISATION CHART OF DEPARTMENT OF CONSUMER AFFAIRS (As on: 12th July, 2022)
