G.S.R. 327.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supercession of the Department of Civil Supplies (Metrological Assistants) Recruitment Rules, 1988, except as respect things done or omitted to have been done before such supercession, the President hereby makes the following rules regulating the method of recruitment to the post of Metrological Assistant under the Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs), namely:—

1. Short title and commencement.—(1) These rules may be called the Department of Consumer Affairs (Metrological Assistant) Recruitment Rules, 2002.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number, classification and scale of pay.—The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

Method of Recruitment, age limit, other qualifications, etc.—The method of recruitment to the said post, age limit, qualifications and other matters relating thereto shall be specified in columns 5 to 1 of the said Schedule.

4. Disqualification—No person,—

- (a) who has entered into or contracted marriage with a person having a spouse living; or
 - (b) who having a spouse living, has entered into or contracted a marriage with any person,
- shall be eligible for appointment to the said post :

Provided that the Central Government may, if satisfied that such marriage is permissible under personal Law applicable to such person and the party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.

6. Savings.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.

(2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।
2. उपभोक्ता मामले विभाग, (माप विज्ञान सहायक) भर्ती नियम, 2002 की अनुसूची में,—
(1) स्तम्भ-4 में,
(क) शीर्षक के स्थान पर, 'वेतन बैंड और ग्रेड वेतन/वेतनमान' शीर्षक रखा जाएगा।
(ख) विद्यमान प्रविष्टि के स्थान पर, 'वेतन बैंड-2 के साथ 9300-34800 रु. के साथ 4200 रु. का ग्रेड वेतन' प्रविष्टि रखी जाएगी।
(2) स्तम्भ-11 में, 'सीधी भर्ती' शीर्षक के अधीन मद (क) की उप मद (ii) में,
(क) '5000-8000 रुपए के वेतनमान में' शब्दों और अंकों के स्थान पर '9300-34800 रुपए के वेतन बैंड-2 के साथ 4200 रुपए के ग्रेड वेतन में' शब्द और अंक रखे जाएंगे।

G.S.R. 59.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Department of Consumer Affairs (Metrological Assistant) Recruitment Rules, 2002, namely :—

1. (1) These rules may be called the Department of Consumer Affairs (Metrological Assistant) Recruitment Amendment Rules, 2010.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Schedule to the Department of Consumer Affairs (Metrological Assistant) Recruitment Rules, 2002,
(1) in column 4,—
(a) for the heading, the heading "Pay Band and Grade Pay/Pay Scale" shall be substituted;
(b) for the existing entry, the entry "PB-2 of Rs.9300-34800 with Grade pay of Rs.4200", shall be substituted.
(2) in column 1, under the heading Direct recruitment, in item (a),— in sub-item (ii), for the words letters and figures "in the Scale of pay Rs. 5000—8000", the words, figures and letters "in Pay Band-2 of Rs. 9300-34800 with Grade pay of Rs. 4200" shall be substituted.
(b) in sub-item (iii), for the words letters and figures "in the scale of Pay of Rs.4500-125-7000", the words, figures and letters "in Pay Band-1 of Rs.5200—20,200 with Grade pay of Rs.2800" shall be substituted.
